2008-15 HSAA AMENDING AGREEMENT

THIS AMENDING AGREEMENT (the "Agreement") is made as of the 1st day of July, 2014

BETWEEN:

HAMILTON NIAGARA HALDIMAND BRANT LOCAL HEALTH INTEGRATION NETWORK (the "LHIN")

AND

Hotel Dieu Shaver Health & Rehabilitation Centre (the "Hospital")

WHEREAS the LHIN and the Hospital (together the "Parties") entered into a hospital service accountability agreement that took effect April 1, 2008 (the "HSAA");

AND WHEREAS pursuant to various amending agreements the term of the HSAA has been extended to June 30, 2014;

AND WHEREAS the LHIN and the Hospital have agreed to extend the HSAA for a further nine month period to permit the LHIN and the Hospital to continue to work toward a multi-year HSAA;

NOW THEREFORE in consideration of mutual promises and agreements contained in this Agreement and other good and valuable consideration, the parties agree as follows:

- **1.0 Definitions.** Except as otherwise defined in this Agreement, all terms shall have the meaning ascribed to them in the HSAA. References in this Agreement to the HSAA mean the HSAA as amended and extended.
- 2.0 Amendments.
- 2.1 Agreed Amendments. The HSAA is amended as set out in this Article 2.
- 2.2 Amended Definitions.
 - (d) The following terms have the following meanings.
 - "Schedule" means any one of, and "Schedules" means any two or more as the context requires, of the Schedules appended to this Agreement, including the following:

Schedule A: Funding Allocation

Schedule B: Reporting

Schedule C: Indicators and Volumes

C.1. Performance Indicators

C.2. Service Volumes

C.3. LHIN Indicators and Volumes

2.3 Term. This Agreement and the HSAA will terminate on March 31, 2015.

- **3.0 Effective Date.** The amendments set out in Article 2 shall take effect on April 1, 2014. All other terms of the HSAA shall remain in full force and effect.
- **4.0 Governing Law.** This Agreement and the rights, obligations and relations of the Parties will be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein.
- **5.0 Counterparts.** This Agreement may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.
- **6.0 Entire Agreement**. This Agreement constitutes the entire agreement between the Parties with respect to the subject matter contained in this Agreement and supersedes all prior oral or written representations and agreements.
